You worked on DD MM YYYY  2 0	You cannot get OSPP if you work during any week of the Ordinary Paternity Pay Period for me or for a new employer.		

Your earnings were too low.	To get OSPP your average earnings must be at least equal to the Lower Earnings Limit. Your earnings during the relevant period, including those under any Class 1B arrangement, were insufficient for you to qualify for OSPP.
